Express Entry Human Capital Priorities Stream

STREAM REQUIREMENTS

Work Experience : You may be eligible under the Federal Skilled Workers Program or Canadian Express Class.

1. Under Federal Skilled Workers Program, you must have:

- At least one year of continuous paid full-time work experience (or the equivalent in paid part-time work) in TEER Category 0, 1, 2 or 3 of the National Occupational Classification (NOC)

Your work experience must have been:

- Obtained within the last five years from the date of submitting your application to the OINP
- In the same primary occupation as you identified in your Express Entry profile

You may have gained your work experience in Canada or overseas.

Continuous means: no breaks in employment over a one year period

2. Under Canadian Experience Class, you must have:

- At least one year of cumulative paid full-time work experience (or the equivalent in paid part-time work) in Canada in TEER Category 0, 1, 2 or 3 of the NOC

Your work experience must have been:

- Obtained within the last three years from the date of submitting your application to the OINP
- In one or more of the occupations that you identified in your Express Entry profile
- In Canada while maintaining legal status in Canada

Cumulative means: the work you've done must add up to one year – it does not have to be one year of continuous work

Education: Applicants trying to target this stream must have a minimum of Canadian bachelor's or its equivalent in another country. Although Nurses are not required to demonstrate that they meet the education requirement if they meet the following conditions.

- They are registered by the College of Nurses of Ontario (CNO) in the General, Extended, or Temporary class
- Their primary NOC falls under one of the following occupations:
 1. NOC 31300 – Nursing coordinators and supervisors
 2. NOC 31301 – Registered nurses and registered psychiatric nurses
 3. NOC 31302 – Nurse practitioners
 4. NOC 32101 – Licensed practical nurses

Language: Applicants must have a CLB level 7 in either English or French. Before submitting the application under this stream, an approved English or French test must be taken to prove the mandatory skills, and the test must be valid at the time of submission of the application.

Settlement funds:

- Applicants must show they have enough money to support themselves and any dependent family members.
- You can meet this requirement through one or a combination of any of the following:
 1. Funds as demonstrated by the balance listed in bank statements, or statements of accounts showing other investments such as non-locked in, fixed term deposits, mutual funds, etc.
 2. Annual earnings from ongoing employment in Ontario
 3. A job offer in Ontario

Intention to live in Ontario

Applicants must show the intention to live in Ontario

You must intend to live in Ontario after you've been granted permanent residence. We determine this by examining your ties to Ontario, which can include doing things like:

1. Working or having worked in Ontario
2. Getting job offers or applying/interviewing for jobs
3. Studying
4. Volunteering
5. Leasing or owning property
6. Visiting
7. Having professional networks and affiliations, family ties and personal relationships
